
Tidewater NCMA Supports Clean the Base Day














NCMA Host Mr. Bill Clifford of BAE

The Tidewater Chapter of NCMA was honored to host Mr. Bill Clifford, as our guest speaker on August 20, 2014, at the Breezy Point Officers Club on Naval Station Norfolk. Mr. Clifford is president of BAE Systems Ship Repair, a leading non-nuclear ship repair, modernization and overhaul company based in Norfolk, Va. Mr. Clifford provided a very lively discussion that challenged many perceptions and opinions of the audience since most were Government Employees.

BAE Systems Ship Repair services the U.S. Navy and other defense agencies, such as the Military Sealift Command, the Maritime Administration, the U.S. Army and the U.S. Coast Guard. Ship Repair's commercial market includes

tankers, cargo ships and cruise ships such as Disney, Carnival Cruise, Holland-America and Royal Caribbean Cruise lines. In addition, the company is actively engaged in several important new construction projects in support of the Gulf of Mexico and inland waterways.

Mr. Clifford leads more than 5,000 highly-skilled employees while managing full-service shipyards and worksites strategically located in Norfolk, VA; Jacksonville and Mayport, FL; Mobile, AL; San Diego and San Francisco, CA; and Pearl Harbor, HI.

Mr. Clifford served on active duty in the U.S. Navy for 20 years, including tours on the USS Wallace L. Lind, the USS Ault, the USS Fairfax County and the USS Papago, where he was the commanding officer. He is a 1969 graduate of the U.S. Naval Academy and earned a master's degree in mechanical engineering from the Navy's Postgraduate School in Monterey, Calif.

In support of the local Hampton Roads community, Mr. Clifford is a member of the USO (United Service Organizations) Hampton Roads Board of Directors, the Virginia Ship Repair Association Board of Directors, and the Hampton Roads Military and Federal Facilities

Alliance (HRMFFA) Board of Directors.

Mr. Clifford's presentation to NCMA could be titled "A Day in the Life of a Private Sector Industry Leader". He described the type of issues he deals with on a daily basis and the many considerations and thought processes he uses to determine the direction he wants to take his company to serve, both the U.S. Navy as the customer and his shareholders. Mr. Clifford discussed the pros and cons of the various contracting strategies used by the Navy and some of his concerns shifting from a Cost-Plus to a Firm-Fixed Price strategy. Mr. Clifford's discussion points were extremely interesting, thought provoking and insightful and helped the audience understand the complexities of doing contracted work with the U.S. Navy and dispelled some myths and perceptions. It was a pleasure to have him as a guest speaker.

Trying to Establish On line links for NCMA Shirts and Coins


With the updated web site, National is trying to establish and online store with direct links to vendors for NCMA shirts, coins and other items.
